# First Amendment to Declaration of Covenants, Conditions, and Restrictions for Heritage Key Villas

This First Amendment to Declaration of Covenants, Conditions, and Restrictions for Heritage Key Villas ("Amendment") is made this 171 day of Dancer, 2006 by FLPRD, LLC, a Florida limited liability company, whose address is 1701 Porter SW, Suite 6, Wyoming, MI 49519 ("Developer"). Capitalized terms used in this Amendment shall have the meanings ascribed to such terms in the Declaration (defined below) unless the context otherwise requires and states.

### Recitals

- A. Developer recorded that certain Declaration of Covenants, Conditions, and Restrictions for Heritage Key Villas in Official Records Book 3053, Page 1388, Public Records of Osceola County, Florida ("Declaration").
- B. The legal description of the Land Submitted to Declaration as described in Exhibit "A" of the Declaration is incorrect.
- C. Developer desires to amend the Declaration to correct the legal description of the Land Submitted to Declaration, and replace the former legal description in its entirety with Exhibit "A" attached to this Amendment.
- D. Due to a scrivener's error, the legal description of the Land Subject to Annexation as described in Exhibit "B" of the Declaration is incorrect.
- E. Developer desires to amend the Declaration to correct the legal description of the Land Subject to Annexation, and replace the former legal description in its entirety with Exhibit "B" attached to this Amendment.
- D. Pursuant to Section 20.1 of the Declaration, Developer has the right to unilaterally amend the Declaration.

Now, therefore, Developer, in accordance with its reserved rights under Section 20.1 of the Declaration hereby amends the Declaration as follows:

- 1. Recitals. The recitals set forth above are true and correct and incorporated in this Amendment.
- 2. Land Submitted to Declaration. Exhibit "A" of the Declaration is hereby deleted in its entirety and replaced with Exhibit "A" attached to this Amendment.

- 3. <u>Land Subject to Annexation</u>. <u>Exhibit "B"</u> of the Declaration is hereby deleted in its entirety and replaced with <u>Exhibit "B"</u> attached to this Amendment.
- 4. <u>Declaration Remains in Effect</u>. Except as expressly modified by this Amendment, the Declaration shall remain in full force and effect.
